FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE came before the Court for final hearing on this 23rd day of October 2024, upon the Petitioner/Wife, **KIMBERLY SUE BOLAND'S**, ("Wife") Verified Petition for Dissolution of Marriage, for Partition and for Other Relief, and the Respondent/Husband **THOMAS JOSEPH BOLAND'S**, ("Husband") Answer to the Verified Petition for Dissolution of Marriage, for Partition, and for Other Relief, and the Court, having reviewed the Marital Settlement Agreement entered into by the parties on October 2, 2024, and having been filed with the Court on October 2, 2024, and having reviewed the pleadings, heard testimony of the Wife, who produced a valid Florida Driver's License to corroborate her residency, and being otherwise fully advised in the premises, makes the following findings of fact and conclusions of law:

- 1. This Court has jurisdiction over the subject matter and the parties hereto only to the extent necessary to enter a Final Judgment dissolving the marriage.
- 2. The Wife has been a resident of the State of Florida for more than six (6) months before the filing of Wife's Petition for Dissolution of Marriage.
- 3. The Petitioner/Wife, **KIMBERLY SUE BOLAND** and the Respondent/Husband, **THOMAS JOSEPH BOLAND**, were married to each other on March 6, 1993.
- 4. The marriage between the Parties is IRRETRIEVABLY BROKEN.
- 5. The parties have children together; however, all children have reached the age of

majority. No other children are in expectancy, none were adopted, and the Wife is not pregnant.

- 6. The Wife has requested that this Court restore her maiden name so that she shall henceforth be known as **KIMBERLY SUE WADDELL**. The Wife has never been adjudicated bankrupt; never been convicted of a crime; and she does not have any money judgments against her.
- 7. The Parties entered into a Marital Settlement Agreement on October 2, 2024, which was filed with the Court on October 2, 2024.
- 8. The Marital Settlement Agreement was entered into freely and voluntarily, and resolves all matters related to their dissolution of marriage.

THEREFORE, it is ORDERED AND ADJUDGED:

- A. The Court dissolves the marriage between the Parties and the Parties are restored to the status of being single.
- B. The Marital Settlement Agreement entered into by the parties on October 2, 2024, and filed on October 2, 2024, is hereby approved, ratified, confirmed, and adopted by the Court and made part of this Final Judgment and is incorporated by reference, but not merged herein, and the parties are ordered to obey all of the provisions of the Marital Settlement Agreement.
- C. The Wife's name shall be restored to her maiden name, KIMBERLY SUE WADDELL.
- D. This Court reserves jurisdiction to modify and enforce all terms and conditions of the parties' Marital Settlement Agreement and this Final Judgment.
