The Marital Settlement Agreement, entered into between the parties hereto on June 9, 2022, and filed with the Court on June 15, 2022, is hereby made a part of this Final Judgment and Decree, and both parties are hereby ordered to comply with the terms thereof.

Additionally, the Court incorporates by reference the Child Support Worksheets, Child Support Addendum, and Parenting Plan. All are hereby made part of this Final Judgment and Decree, and both parties are hereby ordered to comply with the terms thereof.
