**AGREED ORDER ON PETITIONER'S MOTION FOR CONTEMPT, SANCTIONS,  
ATTORNEY FEES AND COST**

**THIS CAUSE**, having come before the Court upon an agreement of the parties on the Petitioner's Motion for Contempt, Sanctions, Attorney Fees and Cost. The Court having reviewed the file, having been advised of the parties' agreement, and being otherwise fully advised in the premises, it is;

**HEREBY ORDERED AND ADJUDGED:**

1. The Petitioner's Motion for Contempt, Sanctions, Attorney Fees, and Costs filed is hereby deferred.
2. The parties agree to retain the services of Matthew Lundy, Esq., to determine the value of the marital portion from all of Respondent/Former Husband's pensions except for the DROP as referenced in the party's marital settlement agreement. The Marital portion is defined as from the date of marriage February 1, 2003, through the filing of the Petition of Dissolution of Marriage on June 29, 2015.
3. All costs associated with the services and retention of Matthew Lundy, Esq., shall be equally divided (50% Former Husband and 50% Former Wife).

4. The parties shall have five (5) days from the entry of this order to retain the services of Matthew Lundy, Esq., Ph: 1-855-737-6529, email at [info@MLundyLaw.com](mailto:info@MLundyLaw.com), and <https://www.mlundy.com/>.
5. Upon receiving the amount owed to the Former Wife by Former Husband from his pension, the Former Husband shall pay the Former Wife the amount owed within 30 days.
6. The Court retains jurisdiction to enter such further orders as it relates to enforcement of the parties marital settlement agreement and the terms and provisions of this order.
