FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE came to be heard on March 21, 2023, upon the Husband's Verified Petition for Dissolution of Marriage and Other Relief with Minor Children. After taking testimony and other evidence in open Court and reviewing the Court file, the Court makes the following

FINDINGS OF FACT:

1. The Court has jurisdiction of the parties and the subject matter herein.
2. The parties were married to each other on October 28, 2011 in King County, Washington.
3. The marriage of the parties is irretrievably broken.
4. There are is one (1) minor child of the marriage, to wit:
George Gabriel Campa, born April 5, 2015.
5. The Petitioner has been a resident of the State of Florida for at least six (6) months prior to the filing of the Petition for Dissolution of Marriage.
6. Irreconcilable differences exist and have caused the irretrievable breakdown of the marriage.
7. The parties have settled between themselves their respective rights, duties, and obligations regarding property and liabilities, and entered into a written Marital

Settlement Agreement and Parenting Plan, which was filed with the Court on February 3, 2023 and attached hereto as Exhibit "A." The Marital Settlement Agreement and Parenting Plan were entered into voluntarily by each party, and have been filed with the Court and introduced into evidence at the Final Hearing in this cause.

IT IS, therefore, **ORDERED** and **ADJUDGED** as follows:

1. The parties are awarded Judgment for Dissolution of Marriage, and the bonds of matrimony heretofore existing between AGNIESZKA CAMPA (hereinafter referred to as "Wife") and JOHN CAMPA (hereinafter referred to as "Husband") are hereby dissolved.
2. The Marital Settlement Agreement ("Agreement") and Parenting Plan of the parties are incorporated, but not merged, into this Final Judgment. They are cited herein by reference for all purposes and are approved and expressly made a part of this Final Judgment for Dissolution of Marriage. All of the terms and provisions of said Agreement and Parenting Plan are **RATIFIED, CONFIRMED, and ADOPTED** as Orders of this Court to the same extent and with the same force and effect as if its terms and provisions were set forth verbatim in this final Judgment, and the parties are ordered to comply with the terms and provisions of said Agreement and Parenting Plan.
3. The Marital Settlement Agreement and Parenting Plan are signed by both parties, and were executed voluntarily, after full disclosure, and is in the best interests of the parties and minor child. They are approved by the Court, are incorporated in this judgment by reference, and the parties are ordered to comply with them. Notwithstanding the incorporation of the Marital Settlement Agreement and Parenting Plan into this Final Judgment, the Marital Settlement Agreement and Parenting Plan shall not merge into this Final Judgment but rather shall survive as an independent contract between the parties.

4. The Court expressly retains jurisdiction of this cause for the purposes of enforcing, construing, interpreting, or modifying the terms of this Final Judgment and the terms of the Marital Settlement Agreement and Parenting Plan entered into by the parties herein, to the extent permitted by Florida law.
5. Jennifer L. DeVries, Esq. is hereby discharged as attorney of record on behalf of the Husband and Dustin Sedor, Esq. is hereby discharged as attorneys of record on behalf of the Wife and relieved of further responsibility in this action.
