B.The Marital Settlement Agreement executed by the parties and filed with this court are ratified and incorporated by reference and made part of this Judgment, but not merged herein, and the Parties are ordered to obey all of their provisions.

C. The Wife's name shall be restored to : MELISSA MARIA DI DOMENICO

D. This Court reserves jurisdiction to enforce and modify any terms and conditions of this Final Judgment and the Marital Settlement Agreement.
